

#### VISITING STUDENT STATUS

Visiting Student is a non-degree status for students who are in the process of completing an MBA degree from an institution outside the Twin Cities, but who are no longer within commuting distance of their home school and wish to take coursework at the University of Minnesota to complete their degrees. To be eligible to apply for this status at the Carlson School, the original institution/program **must** be AACSB Accredited.

Admission to Visiting Student status is based on high academic performance in the student's current MBA program. Students admitted to Visiting Student status are permitted to register in the Part-Time MBA Program for up to two years. Registration is on a space available basis only; priority for classes is given to current Carlson School Part-Time MBA students. Students in the Visiting Student status are subject to current Part-Time MBA tuition and fees.

The MBA Programs office will notify you of an admission decision approximately four to six weeks after receiving your complete application. You will be notified of class availability two weeks prior to the start of the semester.

#### APPLICATION MATERIALS

With this application you must include:

- Visiting Student application form
- An official transcript from your current institution/MBA program
- An official GMAT or GRE score report
- A current resume
- A statement from your current MBA program agreeing to accept Carlson School coursework in transfer

**International Student (Foreign Student):** i.e. Non-Resident Alien: A person who is not a citizen of the United States and who is in this country on a temporary basis and does not have the right to remain indefinitely. PLEASE NOTE: Resident Aliens: Non-citizens who have been fully admitted for permanent residence (who hold a green card, Form I-151) are not international students.
